Regulation 5 of the Water Supply (Water Fittings) Regulations 1999 makes it a legal requirement to notify Yorkshire Water of certain planned plumbing works. Full details of the type of work can be found at [Water Regs UK Limited – Notification](#).

- The erection of any new buildings or structures
- The material change of use of any premises
- The extension or alteration of the water system in any premises except a domestic.

The installation of:

- A bidet or WC with an ascending spray or flexible hose
- A bath larger than 230 litres (measured to the centre of the overflow)
- A pump or booster drawing more than 12 litres per minute
- A reverse osmosis unit
- A water treatment unit producing a wastewater discharge or using water for regeneration or cleaning
- A RPZ valve / type BA device [Yorkshire Water RPZ application to Install, relocate or replace](#)
- A garden watering system unless designed to be a hand-operated (irrigation)
- Any water system laid outside a building and either less than 750 mm or more than 1350 mm below ground level

Other items to inform us of:

- Grey water, recycled water, reclaimed water and rainwater harvesting systems
- Water systems for firefighting, including domestic sprinklers
- A 'shower-toilet' or 'bidet- toilet' where, either as part of the WC itself or as an addition or adaptation of it, a stream of water is provided from below the spill over level of the WC pan for personal cleansing
- Any system incorporating a private water supply (e.g., Borehole or Spring supply)
- Any underground storage cistern

Please ensure that you send this completed form and any schematics showing pipework, fittings & back flow prevention devices that you will be installing to Reg5@yorkshirewater.co.uk. Failure to provide a copy of the schematics will result in refusal of consent
