Conditional and / or Technical Acceptance confirms that Yorkshire Water are satisfied the design of the prospective public sewers and associated assets will be constructed in accordance with the Design and Construction Guidance, Local Practices and Technical Standards contained within the Code for Adoption.

Please note, where a site has a diversion incorporated within the S104 application, no works on the diversion should take place until the Legal Agreement has been drawn up and signed by all parties.

Prior to any construction works in relation to the proposed adoptable network starting on site, a pre start inspection meeting must be held. If works have already started prior to the meeting being held, then that is done so at entirely the developers own risk and cost.

Please note that there is a risk that because of the partial nature of a site approval (Conditional Acceptance), changes may be required in order to reach Technical Acceptance, resulting in laid sewers needing to be altered to meet the requirements of the Technically Accepted system. Any alterations required will be at the developers own risk and cost.
